1. **Meeting Called to Order: 9:00 AM; Prayer and Pledge**
2. **Minutes of April 12, 2016 – No corrections noted.**
3. **Public participation and items not on the agenda –** Tonya Dale, Cedar Creek mentioned that the District's Water Education Training (WET) was provided on May 10th & 11th to the 4th graders at the Paradise and Ponderosa elementary schools.
4. **Annual Kid's Fishing Day (KFD) Event (Greg Dobbs / Jim Passanisi)**
 - a. **2017 Kid's Fishing Day Financial Summary and USFS Permit 3% Fee** - Jim Passanisi discussed the summary indicating it provides specific details about planning, expenses and revenues unique to the recent event. More fish were bought this year than previous years. Greg Dobbs mentioned this event may have been the best one to date (1,000 total attendees; 600 kids). Factors include improved advertising, weather conditions, and lack of schedule conflicts with other events. Some post event radio outreach was achieved per Jim Passanisi. Mark Sulik will send an e-mail thanking all staff volunteers. The USFS has not yet provided any information regarding the amount of the 3% fee due to their time constraints.
 - b. **Updating the Kid's Fishing Day Video (Cedar Creek)** – Tonya Dale provided an overview of the video changes this year compared to the video three years ago by using a drone. She mentioned the video will be used for other water education opportunities in the future. Next October, Jim will provide a summary of Kids Fishing Day with a video presentation to the Butte County Fish & Game Commission to help promote our annual grant request for purchasing catchable trout.
 - c. **Senior poster project proposal for future advertising materials for Kid's Fishing Day –** Committee Member David Bermann provided an overview of his proposal. Director Kellogg asked Jim to include the proposal in the consent agenda (information only) for the next Regular Board meeting on May 17th (see attached Board Memo).

4. Project Updates – Informational items.

- a. **North Lake Boat Launch Project Status Report** - Jim Passanisi indicated we are waiting for the Dept. of Boating and Waterways to complete their internal discussions regarding their request for a project commitment letter relative to the District's non-reimbursable expenses.
 - b. **Little Butte Creek Forest Health Project Phase II** - Greg Dobbs provided information regarding the project's smooth progress using both the CCC and the Sheriff's work crews. The Sheriff's work crews are working primarily along the residential properties where the CCC cannot work. Greg indicated the project would need to end sometime in June due to hot weather constraints. **See attached map.**
 - c. **Construction Projects at the Lake** - Greg Dobbs discussed the projects underway or needed in the short term including the following: 1. Installed ADA concrete sidewalk and partial rehabilitation of the old Rotary restroom, 2. Installed the ADA parking, ADA restroom pad, and ADA pathway from the restroom to the ADA trail ending at the gazebo; and 3. Several locations along the storm damaged lake trail needing maintenance and repairs.
 - d. **Update - SPI Timber Harvest Plan** - Kieran O'Leary provided a summary and tentative schedule for their THP. He mentioned that SPI will be constructing a road off of Coutolenc northeast of Northlake Road to provide access to their property for logging.
5. **Discussion of the completed shaded fuel removal projects regarding planning for follow up maintenance work, control burns, and education** - Greg Dobbs and Director Sulik talked about the importance of follow up maintenance projects in project areas previously cleared with grant money. Jim indicated the District has budget appropriations to do this work. Greg and Mark will contact qualified persons to consider the applicability, planning, and implementation of controlled burns.
6. **Discussion of the use of shaded fuel removal to discourage the establishment of homeless camps** - Jim Passanisi discussed using CalFire or the Sheriff's work crews to remove shaded fuel to help alleviate the proliferation of homeless camps near Skyway and Dogtown Road. The work may take up to three days and would need to be coordinated with seasonal weather conditions. The work will be implemented as soon as practical.
7. **Discussion of a sewer spill on Dogtown Road** - Greg discussed the sanitary conditions and concerns regarding the septic system leakage from the Paradise Pines Campground. Jim Passanisi indicated that Magalia Reservoir is 3,000 feet away from the spill location, and no liquid was observed anywhere near the reservoir; and a replacement septic system for the Paradise Pines Campground has been planned and needs permit approval from the State Housing and Community Development.
8. **Discussion regarding the Butte County Planning/Development's Watershed Protection Overlay Zone (WPOZ)** - Jim Passanisi discussed the purpose of the County's Department of Developmental Services (DDS) WPOZ, which is to maintain and improve water quality by establishing additional development standards within sensitive watershed areas. Areas subject to the overlay zone include the Firhaven Creek watershed and the Paradise and Magalia Reservoir watershed, as shown on the **Zoning Map attached**. Included with DDS is Code Enforcement that deals with nuisance abatement relative to impacts on public health among other things. Additional discussion involved the County's Public (environmental) Health Department's involvement with water quality impacts and enforcement.

Director Kellogg asked Jim Passanisi to arrange to have Doug Teeter, County Supervisor attend the next committee meeting to discuss the County's role in responding to water quality contamination incidents, and provide an update regarding the Paradise Pines Campground septic system replacement. Unfortunately, Supervisor Teeter is not available for the next committee meeting on June 21st; however, suitable designees from DDS and Public Health will be arranged by Supervisor Teeter.

9. Paradise Lake Recreation Activity and Project(s) Report (Greg Dobbs / Jim Passanisi). Informational items.

- a. **2017 Permit Sales and Lake Activity** - Greg Dobbs discussed permit sales compared to previous years. Greg discussed activities including, but not limited to the following: 1. Irresponsible patrons; 2. Rule and regulation noncompliance and enforcement with tickets; 3. Threatening (pit bull) dogs; and 4. Adequate signage.
- b. **Discussion of ideas to expand recreational opportunities at Paradise Lake and Magalia Reservoir** - Director Sulik discussed paddle boarding as an opportunity raised at a recent Community Relation Committee meeting. The committee members discussed the negative consequences of this activity. Another opportunity mentioned was a hiking trail from Magalia Reservoir to Paradise Lake. Wade Killingsworth and Greg have discussed a proposed alignment for the trail.
- c. **Use of Sheriff's and CalFire work crews** - Greg Dobbs discussed this item previously in agenda items 4.b., 5 & 6.
- d. **Update on USFS Requirements for Renewal of Special Use Permit for Paradise Lake (Gazebo, restroom access, etc.).** - Greg Dobbs and Jim Passanisi discussed the coordination and collaboration with the Forest Service regarding District projects, and the nexus on F.S. land that must consider the use of their specifications pursuant to the USFS Special Use Permit.

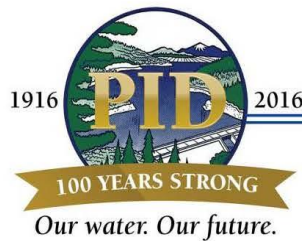
10. Work Schedule for Lake Patrolmen; Return to split shift - Greg Dobbs discussed the advantages of changing to a split shift (7 AM to 11AM & 5 PM to 9 PM) for the summer, versus the current staggered/overlapped shift. The suggested change is primarily due to most of the patron activity in the morning and the late afternoon, with less activity during mid-day; and the earlier and later time of day for sunrise and sunset. Jim mentioned the Lake Patrol officers may use both work schedules depending on the circumstances. There is no schedule that will provide full coverage of the lake with two Lake Patrol Officers. Mark Sulik will research how Bidwell Park is utilizing volunteers and report back to the committee at the next meeting.

Kid's Fishing Day occurs annually in April. The Paradise Irrigation District (PID) committee that works on this advertises in the community for widespread support of this event. It has become a well known and desired event throughout the entire Paradise Ridge, with children of all ages, their families, community groups and individuals participating through donations and energy.

Students in grade 12 at Paradise High School are required to propose and complete a senior project to graduate prior to the completion of their senior year. Currently a student is working with PID to help organize this year's Kids' Fishing Day.

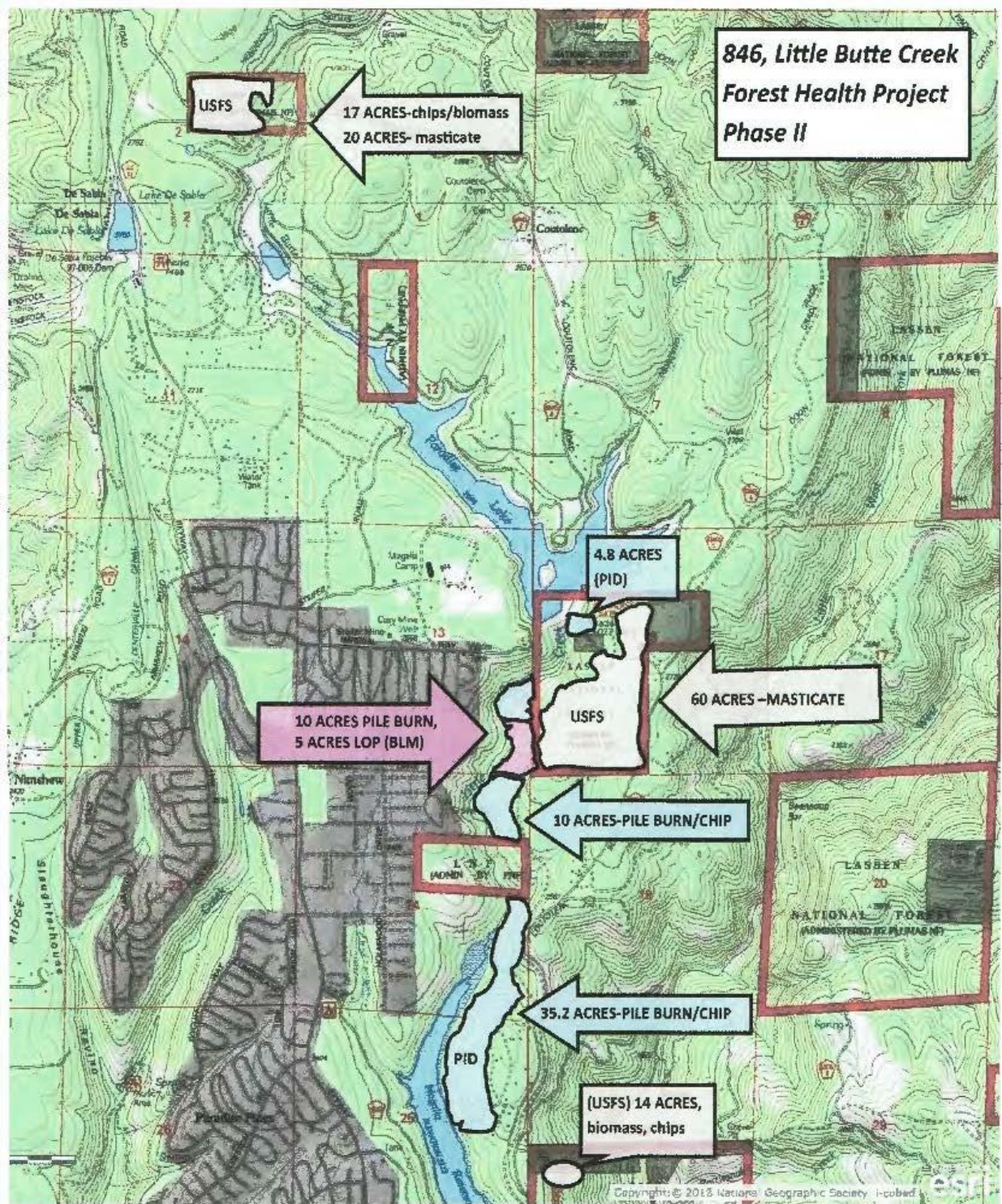
Starting in 2018 and for following years, I propose that one or more students at Paradise High School, working in conjunction with PID and appropriate Paradise High School staff, are offered the opportunity to create and produce posters to be used in advertising upcoming Kids' Fishing Day events.

Requirements for Senior Projects

- Each student is required to have a community mentor with whom they work to fulfill then sign off on the project completion.
- No less than 15 hours of work on the project is required and signed off by their mentor
- Projects have to be oriented toward future vocational goals or community support
- Just prior to graduation, seniors are required to present their projects to a panel of judges from the community, for feedback and to demonstrate completion of the entire process

A Win-Win Situation

- PID gains new, creative ideas from students, their mentors and teachers within the community
- PID will be helping students from our community learn and become productive adults
- Students are given the opportunity to fulfill their Senior Project needs in a constructive way that supports the community and children of all ages
- Students propose their Senior Projects early in the school year, so PID and students have a huge lead time to begin preparing for this activity
- Students learn new and useful skills and apply them to real life situations: graphics, photography, interactions with agencies such as PID and others in the community, under the direction of PHS teachers from various disciplines
- The entire Ridge gains with productive, positively oriented community activities for our children



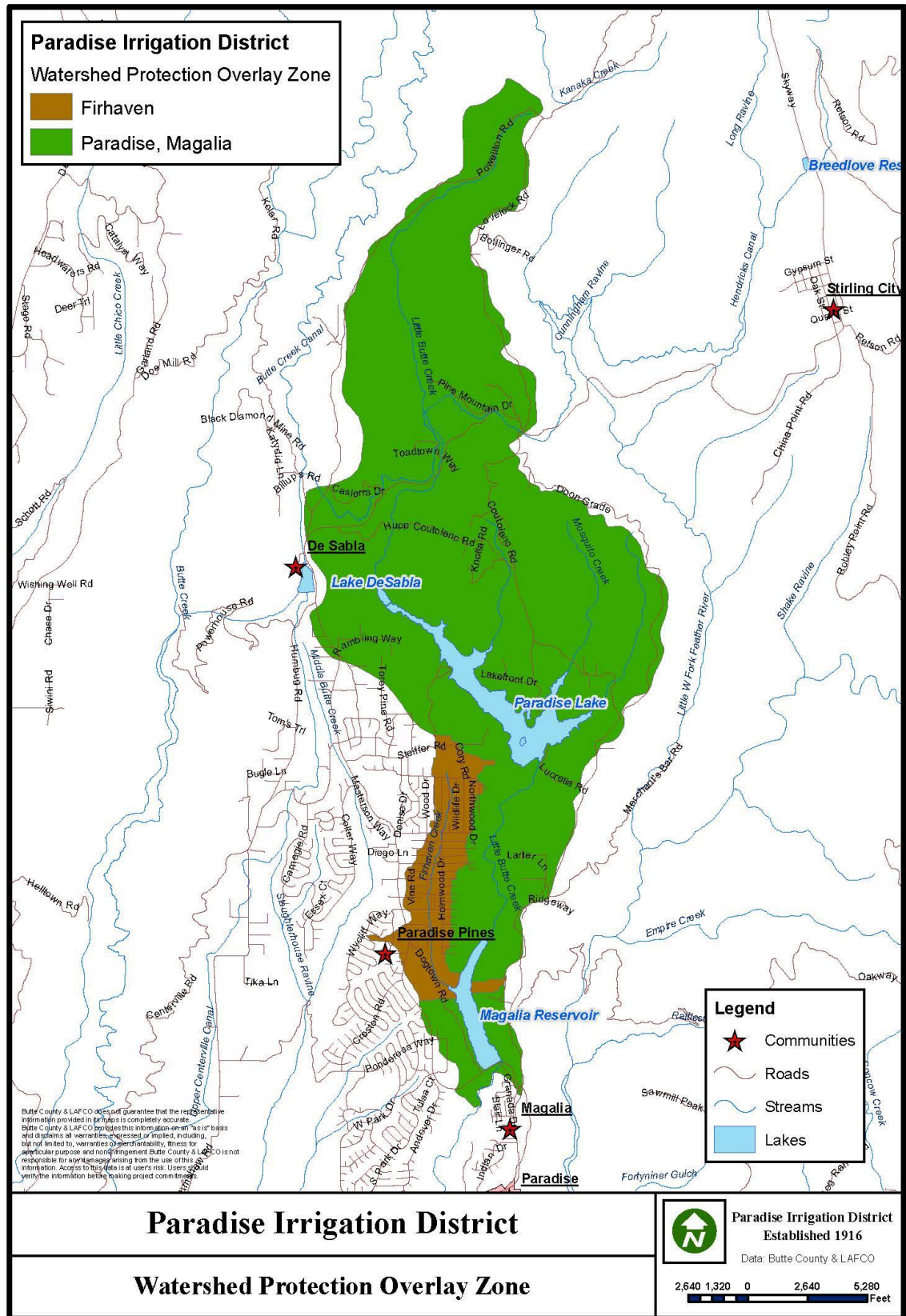

Butte County Development & Planning Division, Land Use Section is responsible for the Watershed Protection Overlay Zone (WPOZ). The WPOZ was updated in the latest version of the Butte County's General Plan Watershed Protection Overlay Zone (Zoning Code 24-46C) adopted November 6 2012. The WPOZ is intended to maintain and improve water quality by establishing additional development standards within the sensitive Little Butte Creek watershed area.

This WPOZ was adopted with the following purposes in mind:

1. Protect the County's surface and ground water resources;
2. Reduce future governmental costs by preserving public water supplies;
3. Recognize the public nature of the land and water resources of a watershed and the continued vitality is directly related to the social and economic welfare of the County and its communities;
4. Protect public health, safety and welfare by requiring restrictions;
5. Use of the land is necessary to retain the natural balance and integrity of the watershed;
6. Recognize the uniqueness of the watershed by basing the selection of the most effective measures for its protection upon an evaluation of the soils, climactic conditions, topography, vegetation, drainage pattern, and any other specific conditions unique to the watershed; and
7. Allows the County or its citizenry to identify where a natural or man-made imbalance in environmental systems may occur and provide a means for repairing or restoring the natural functions of the watershed.

Some of the primary elements of the WPOZ include the following:

1. The only building allowed is new residences on lots that were previously developed, or if there are special circumstances. Thus the impact from further growth within the watershed is minimal;
2. Vegetative buffers shall be maintained within 200 feet of Paradise Lake and Magalia reservoir and 100 feet from any perennial and intermittent rivers and streams;
3. No structures are allowed within the buffers;
4. Grading, excavation, removal of trees, the use of fertilizers and pesticides, sewage disposal, and paving are prohibited within the buffer areas;
5. Septic systems require an additional setback of 50 feet beyond the buffer areas; and
6. Erosion control and timber harvest measures.

Free Fishing Days

Free Fishing Days for 2017 are **July 1 and September 2**

Have you ever felt the excitement of watching your bobber suddenly jiggle, then dive out of sight? Or feeling the tap-tap-tap of a bass as it tastes the worm on the end of your line? Or having a salmon practically tear the rod out of your hands as it smashes your lure? What's that? You say you never learned to fish?

If you are new to the sport of fishing, and not sure if you will enjoy it, a great opportunity awaits you. CDFW offers two Free Fishing Days each year. On these days, you can fish without a sport fishing license. Free Fishing Days provide a great, low-cost way to give fishing a try. Some CDFW Regions offer a [Fishing in the City \(/Fishing-in-the-City\)](#) program where you can go fishing in the middle of major metropolitan areas perhaps just a few blocks from your home. Fishing in the City and free fishing day clinics are designed to educate novice anglers about fishing ethics, fish habits, effective methods for catching fish, and fishing tackle. You can even learn how to clean and prepare your catch so you can enjoy it for dinner that night.

While all fishing regulations, such as bag and size limits, gear restrictions, report card requirements, fishing hours and stream closures remain in effect, there are two days each year when anyone can fish without purchasing a fishing license.

On Free Fishing Days, every angler must have the appropriate [report card \(/Licensing/Fishing#ReportCards\)](#) if they are fishing for:

- abalone
- steelhead
- sturgeon
- spiny lobster
- or salmon in the Smith and Klamath-Trinity River Systems.

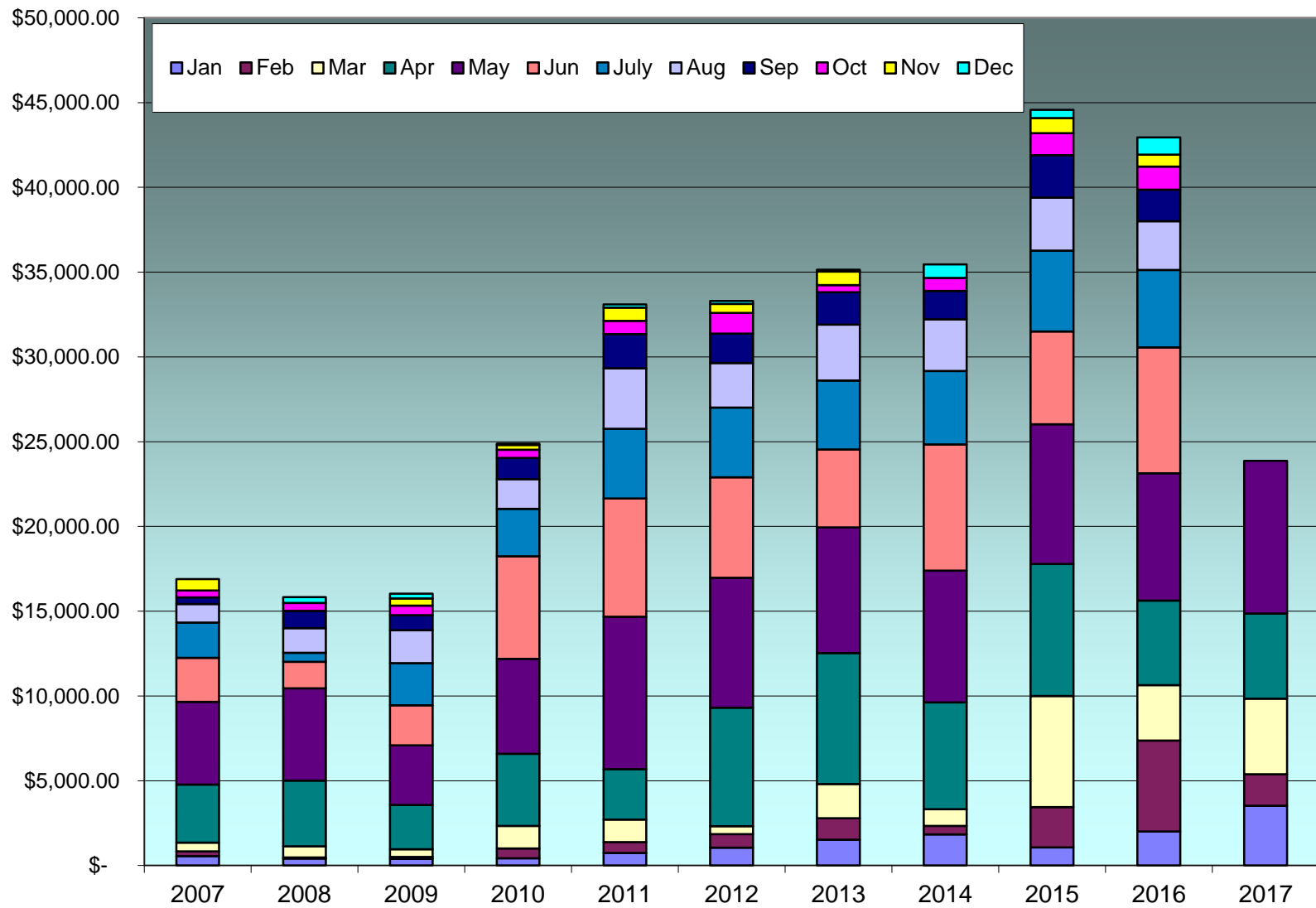
