

- 1. Water Supply update: Jim stated that Paradise Lake remains full and that PID has selected a consulting firm for work on the dam inundation studies for both Paradise Lake and Magalia Reservoir as required by the State. These dams are considered highly hazardous and hazardous, which requires the studies to be completed. It may take approximately 12 weeks to complete the studies. Jim stated we could request that the consultant make a presentation of the studies to the Board of Directors a regular Board meeting.
- 2. Project Updates: Greg stated that the Lake bulletin board is up and there is ongoing discussion of the format and the content to be placed on the bulletin board. A handicap handrail still needs to be installed on the handicap path at the picnic area, but weather constraints have delayed the installation; 2) Lake permit sales are up again this month; 3) CCC crews were working on clearing 4 acres of PID land off Lucretia Road; 4) The Shaded Fuel Project is continuing and they will be working on an area near Magalia down to Skyway where homeless camps have been located. A requirement is that 48 hours advance notice has to be given before any area may be cleared (homeless camp). There was discussion about the possibility of a spraying program to be used after the fuel reduction projects. Bill noted that PRPD sprayed 22 acres of their future park site and that it looked to be effective. It was suggested that a Spraying Program discussion be put on the next PL&RC meeting agenda and the proposed Paradise Reservoir to Paradise Lake trail also to be added to the next agenda; and 5) North Lake Boat Launch Improvement Project: Jim noted that PID is still waiting on the Division of Boating and Waterways response to PID's request to changes in the Grant Funding agreement. The rough grading for the parking area for the expanded boat launching facility is PID's responsibility and not a part of the grant funding. Kieran stated that SPI is currently doing work in the area removing trees and that the timing would be good if PID were to contract the work with Wheeler Logging who is doing the tree clearing for SPI. It would save contractor mobilization costs.
- 3. Annual Kids Fishing Day (KFD): The trout plant was re-scheduled for Sunday, 4/15 in the evening. Mickey Rich planned on flying the District Drone to get photos of the trout planting operation. There will be two more trout stockings coming up in May. The Kids Fishing Day group met to work on details of the event. The Blue Team Realty Co. will have a booth at KFD for kids to paint fish and there will be a PID Directors booth for Directors to interface with the District customers and the public. Greg noted that the Paradise High School JV baseball team members will be volunteering to help out at KFD. Lake Day passes will be given to the volunteers who help out a KFD. Dave noted that the High School KFD senior poster project (proposed) is on hold until next year.
