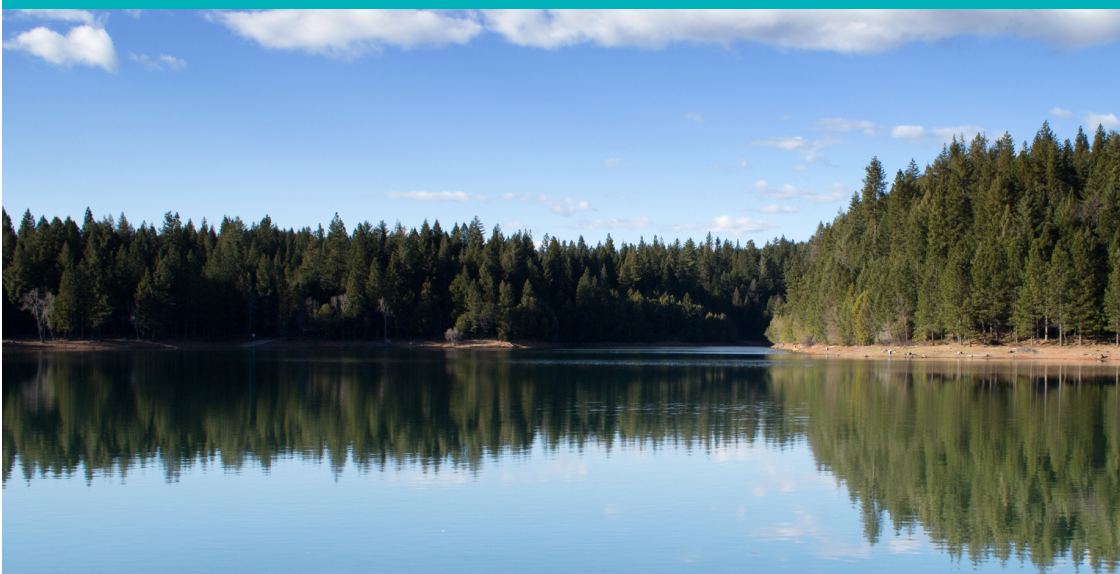

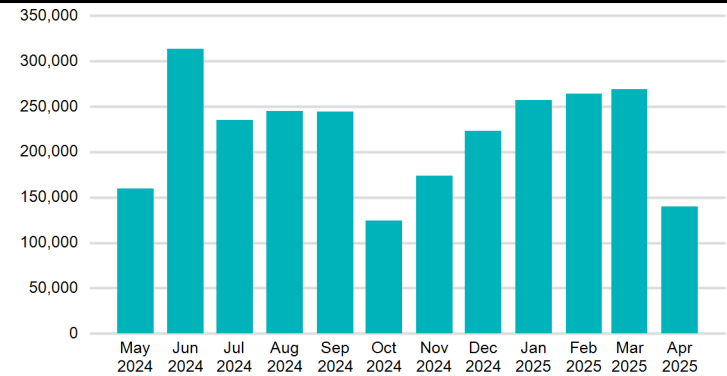

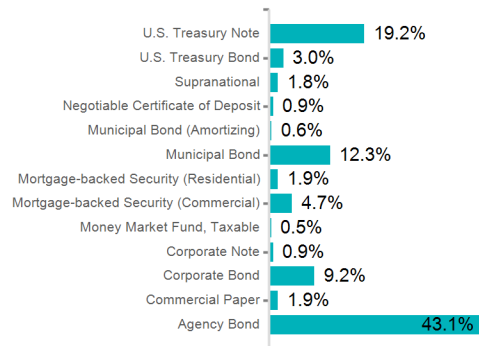

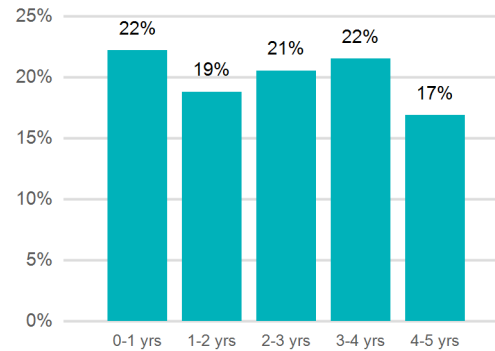
PROJECTED MONTHLY INCOME SCHEDULE



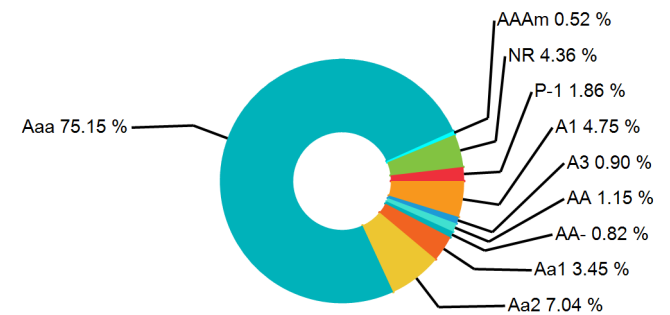
SECTOR ALLOCATION
