RE: D Tank Well – Removal and Replacement of Submersible Pump

August 10, 2021 Special Board of Directors Meeting

The one production well the District owns is located at the D Tank site. It is a 60 HP submersible pump that is 380' down inside of a 10" casing. Last year we had trouble keeping the pump running. The first diagnosis was the soft starter was not working, which it wasn't. The starter was replaced, but even then, the pump would shut down after running for a few minutes. The soft starter was shutting it off due to high amp draw.

On Monday, August 2, 2021, Commercial Pump and Mechanical came out to check the well. The technician performed a thorough check and testing and concluded there is a bad bearing in the pump, which is causing the high amp load. Due to the age of the pump, 23 to 25 years old, they recommend replacing the pump along with the wiring to the pump and checking and replacing any piping at the same time. Bids have been requested to perform this work.

#### The recommended form of motion is:

"I move to provide a one-time approval for the District Manager to authorize up to \$40,000 for the Water Treatment Plant expenditure to provide a new pump, wiring, and perform the work necessary for the removal and replacement of the submersible pump at the "D" Tank Well."
