Minutes of the Ad Hoc Demonstration Garden Committee Meeting

3. Minutes were approved from last meeting.
4. PID Demonstration Garden Landscape Project Update:
 - a. Mike is about halfway done with the construction of the irrigation manifold cover.
 - b. The lumber is here to make the frame. Area needs to be leveled. Anne received 144 ft² of weed block from Paradise Garden Center.
 - c. Kendel absent. Bill will call a special meeting to begin planting as soon as we have a few days of dry weather. John Mendon would like plants removed from his nursery to make room for the new springs plants.
 - d. We received five 5" x 7" colored signs for planting beds. Anne will order a 6th color for Bed F from Awards Company in Chico. She passed around pictures of copper signs that could be used for plant ID. She will ask Paradise Garden Center to donate or discount.
 - e. Anne visited Awards Company and Recognition Products in Chico for ideas regarding the recognition sign on the 3' x 5' bulletin board thanking donors. It was decided to go with a 16" x 12" green on white plastic sign from Recognition Products and ten 1¼" x 3" signs with names of donors not to exceed \$200.
 - f. The archway is being powder coated. Transport arranged by Kevin.
 - g. Anne showed a picture of a cement bench from Paradise Garden Center. She will get a discount price for next meeting.
 - h. Anne passed around the proof of the plaque. It will cost \$525. Possible dedication date May 18, 2018.
 - i. PID has received \$1,250 in cash donations, \$410 in materials and 177 hours of labor to date. Georgeanna provided a list of volunteers.
 - j. Kevin received one bid for landscape maintenance. A one-time clean-up fee of \$350 and then \$150 a month for service twice a month. He will get more.
