**Important Notice:** Beginning January 1, 2015: (a) No contractor or subcontractor may be listed on a bid proposal for a public works project (submitted on or after March 1, 2015) unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5; (b) No contractor or subcontractor may be awarded a contract for public work on a public works project (awarded on or after April 1, 2015) unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5; and (c) All projects are subject to compliance monitoring and enforcement by the Department of Industrial Relations.

All contractors and subcontractors who bid on work on a public works project must register and pay an annual fee to DIR. Contractors may register at: <https://efiling.dir.ca.gov/PWCR/ActionServlet?action=displayPWVRegistrationForm>
